> Expenses are based on initial fees, competition fees, and miscellaneous expenses in uned throughout the year. Initial expenses induce, but are not limited to, summer camp, practice dothes, shoes, warmups, uniforms, badquads, megaphone, and accessories. Competition fees induce, but are not limited to, travel expenses which may induce hotel, transportation, meals, entry fees, and entertainment. Miscellaneous expenses induce, but are not limited to, spirit sticks, decorations, peptally outfits, meals, and special events. (Costs may be offset by functioning which begins shortly after tryouts).
